***Teaching Plaque Fee:***

***(effective January 1st, 2004)***

The membership fee for each individual who teaches ITF TKD, i.e. Grand Masters, Masters, Instructors, and Assistant Instructors) is 60.00 USD for one year or 100.00 USD for two years.

The organization that collects the fees will keep 10.00 USD of the annual fee (or 15.00 USD for two years) and use the funds to pay for travel to participate in official ITF activities (such as ITF Congress Meeting, Annual International Technical Conference, World Championship, World Cup).

Black Belt members receive an official ITF certificate as well as a small certificate in the form of a laminated card with a photograph of the holder.

### ***ITF FEE SCHEDULE REDUCTION***

When you pay your membership fee on promotion to a new Degree a certificate will be sent to you. Some countries may have a reduction of the fee and our table is in accordance with the World Bank Guidelines. The headings indicate which group your country is in and what percentage of the fee should be paid to the ITF. Those countries who pay the full price are entitled to deduct 5 percent for the association and 20 percent for the examiner. When the Country pays 50 percent of the full price then 5 percent from the 50 percent is for the association and 20 percent of the 50 percent is for the examiner. When the Country pays 25 percent of the full price then 5 percent from the 25 percent is for the association and 20 percent of the 25 percent is for the examiner.
